The RE Store, a project of RE Sources, diverts reusable building materials, tools, and furniture from the landfill while modeling a circular economy for Northwest Washington. In 2025, the RE Store diverted an estimated 2.88 million pounds of materials program-wide - an 11% increase over 2024 - through retail sales, store donations, item pickups, contract salvage services, and manufacturing waste diversion partnerships with local businesses. Our Salvage Services team completed 19 jobs, recovering high-quality architectural materials that would otherwise be lost to demolition and remodel waste, and continued refining salvage into a reproducible regional model through participation in a local construction and demolition summit. Our Manufacturing Waste Diversion program added four new business partners in 2025, diverting an estimated 103,844 pounds of materials. The RE Store also creates pathways to green jobs through our Community Jobs Training Program, where 65 participants logged 3,815 hours of hands-on training in 2025. Ninety percent of participants who complete the program find employment or enroll in college.

Northsound Waterkeeper: RE Sources serves as the Northsound Waterkeeper, filling critical water quality knowledge gaps that public agencies lack the capacity to address - providing the science necessary to keep Northwest Washington's waters safe for swimming and shellfish harvesting. In 2025, 19 volunteers conducted monthly water quality testing of four urban creeks and ten outfalls flowing into Bellingham Bay, sampling in all weather conditions to provide consistent, reliable data on stormwater - the Salish Sea's largest source of pollution. Our Year 4 Stormwater Summary Report found that all monitored outfalls and creeks failed to meet water quality standards at least once during the sampling period. This marked our third consecutive year testing for PFAS (forever chemicals) during the first fall flush; while fewer sites showed high concentrations, the median total of PFAS has increased each year. Staff monitored six lakes for harmful algal blooms monthly, reporting findings to Whatcom County Health and Human Services and Western Washington University. We published four white papers on the state of water quality, bacteria, PFAS, and pollution in Bellingham Bay. Joined by 230 volunteers, we hosted six beach cleanups and four paddle sweeps, removing more than 3,300 pounds of trash from local waterways.

Land, Water, and Climate Advocacy: RE Sources advocates for the forests, watersheds, and climate policies that protect Northwest Washington's land and water for generations to come. In 2025, we convened monthly strategy sessions with more than 30 Forest Watch coalition members and continued monitoring DNR's implementation of the "Forest Forward" executive order, which proposes conservation of 77,000 acres of Structurally Complex Forest across Western Washington, including critical parcels in Whatcom County. We supported robust public engagement on the Lake Whatcom Forest Management Plan - a draft plan to manage nearly 12,000 acres of forest land in the Lake Whatcom watershed for water quality and climate resilience - and continued supporting the Lake Whatcom Policy Group in addressing key issues raised during public comment. We celebrated the installation of the first-ever off-season boat launch gate at Bloedel Donovan Park, an additional protection for Bellingham's drinking water supply. RE Sources also advocated for climate resilience through comprehensive plan updates in Whatcom and Skagit Counties and the City of Anacortes. Our priorities were incorporated into the final Skagit County Comprehensive Plan, which includes a new Climate Element with forward-thinking guidelines for reducing greenhouse gas emissions and adapting to climate impacts including sea level rise and hazardous flooding.

Schedule L, Part II - Loans from Interested Persons: RE Sources held bridge loans from three former and current board members totaling \$90,000 to ensure organizational liquidity while awaiting repayment of an Employee Retention Credit (ERC) from the IRS. The ERC reflects expenses originally incurred to retain RE Store staff during the COVID-19 shutdown. Two loans, totaling \$50,000, are low-interest, documented by written agreements, and structured for repayment upon receipt of the ERC. A third loan of \$100,000 is structured as a low-interest installment loan with a \$20,000 annual repayment schedule. These loans reflect the board's personal commitment to protecting RE Sources staff and operations during a period of federal payment delays.
